BY-LAW NO. 2017 - 25

A by-law of the City of Ottawa to establish fees and charges for the sale of City merchandise provided through Service Ottawa and to repeal By-law No. 2016-17.

WHEREAS at its meeting of December 14, 2016, by way of Motion 43/6, Council approved the 2017 budget including the increase of or creation of certain fees and charges to come into effect on January 1, 2017;

AND WHEREAS By-law No. 2016-423 confirms the proceedings of Council of December 14, 2016;

NOW THEREFORE the Council of the City of Ottawa enacts as follows:

1. Council hereby establishes the fees and charges as set out in Schedule "A" to this by-law for the Client Services Branch.
2. No request by any person for any merchandise, information, service or activity described in Schedule "A" will be processed or provided unless and until the person requesting the merchandise, information, service or activity described in Column 1 of Schedule "A" has paid the applicable fee or charge as set out in Column 2 of Schedule "A" to this by-law.
3. The fees or charges listed in Column 2 of Schedule "A" of this by-law will be subject to Harmonized Sales Tax (H.S.T.) or any successor sales tax program thereto, where applicable.
4. By-law No. 2016-17 entitled "A by-law of the City of Ottawa to establish fees and charges for the sale of City merchandise provided through Service Ottawa services" is repealed.
5. This by-law shall be deemed to have come into force and effect on January 1, 2017.
