BY-LAW NO. 2017 - 58

A by-law of the City of Ottawa to change the names of avenue Lees Avenue, rue Botsford Street, rue Blair Street, avenue Emslie Avenue, and chemin Cedarview Road, municipal highways in the City of Ottawa.

WHEREAS the Council of the City of Ottawa desires to assign a new name to certain municipal highways in the City of Ottawa;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. That "avenue Lees Avenue" in the City of Ottawa, described in Schedule "A" shall be assigned the name "avenue Robinson Avenue".
2. That "rue Botsford Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Botsford Street Sud/South".
3. That "rue Blair Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "voie Neighbourhood Way".
4. That "avenue Emslie Avenue" in the City of Ottawa, described in Schedule "A" shall be assigned the name "place Bogen Place".
5. That "chemin Cedarview Road" in the City of Ottawa, described in Schedule "A" shall be assigned the name "promenade William McEwen Drive".
6. That "chemin Cedarview Road" in the City of Ottawa, described in Schedule "A" shall be assigned the name "chemin Borrisokane Road".
7. That Schedule "A" form part of this by-law.
8. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
