BY-LAW NO. 2017 - 60

A by-law of the City of Ottawa to correct the spelling of the name “boulevard St. Laurent Boulevard”, a municipal highway in the City of Ottawa.

WHEREAS the Council of the City of Ottawa desires to correct the name of a certain municipal highway in the City of Ottawa;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. That “boulevard St. Laurent Boulevard” in the City of Ottawa, described in Schedule “A”, shall be assigned the name “boulevard St-Laurent Boulevard”.
2. That Schedule “A” form part of this by-law.
3. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
