BY-LAW NO. 2017 - 69

A by-law of the City of Ottawa to repeal By-law No. 2017-31 and to amend By-law No. 2012-370 respecting fees and charges for solid waste services.

NOW THEREFORE Council of the City of Ottawa enacts as follows:

1. Schedule "A", Fees and Charges, of By-law No. 2012-370 entitled "A by-law of the City of Ottawa to provide for solid waste management and to repeal by-law 2009-396", is repealed and the Schedule "A" attached hereto is substituted therefor.
2. This by-law includes Schedule "A" annexed hereto and Schedule "A" is hereby declared to form part of this by-law.
3. By-law No. 2017-31 entitled "A by-law of the City of Ottawa to amend By-law No. 2012-370 respecting fees and charges for solid waste services." is repealed.
4. This by-law shall come into force and take effect on March 1, 2017.

SCHEDULE "A"
FEES AND CHARGES

WASTE COLLECTION FEES

1. The annual fees for residential garbage collection, levied on the municipal tax bill, are payable at the time of payment of municipal taxes as follows:
 - (a) \$84.00 per dwelling unit of each separate municipal tax assessed property receiving residential curbside collection; and
 - (b) \$41.00 per dwelling unit of each separate municipal tax assessed property receiving multi-unit bin tipping collection.

2. In the case of payments received by mail, the date the payment is received by the City shall be taken as the day of payment.

3. The fee per garbage bag, payable at the time of purchase from a City retailer, for waste to be collected through the Yellow Bag program is \$3.75 per bag.

WASTE DIVERSION FEE

4. The fee for purchasing an additional blue or black box container from the City or one of the City's retailers is nine dollars and ninety-nine cents (\$9.99) per box. The fee for purchasing a 46 litre green bin is twenty-nine dollars and ninety-nine cents (\$29.99), for an 80 litre green bin is thirty-nine dollars and ninety-nine cents (\$39.99) and the kitchen organics container is eight dollars and ninety-nine cents (\$8.99)

FEES AT THE TRAIL WASTE FACILITY

5. The fee for unloading or disposing of any material at the Trail Waste Facility is subject to the following charges:

Garbage (100 kg or less) Private or Commercial Motor Vehicles	\$ 10.80 per load
Special consideration items, hauled by generating residential household.	Free
Garbage (greater than 100 kg)	\$ 108.00 per tonne
Mixed Garbage and recyclable material (100 Kg or less) minimum	\$21.60 per load
Mixed Garbage and recyclable material (100 Kg or more)	\$216.00 per tonne
Commercial Leaf and Yard Waste under 10 cm in diameter Minimum (less than 100 kg)	\$5.20
Commercial Leaf and Yard Waste	\$ 52.00 per tonne

(greater than 100kg)	
Residential Leaf and Yard Waste under 10cm in diameter minimum (less than 100 kg)	\$5.20
Cardboard minimum (less than 100 kg)	\$ 5.20
Cardboard (greater than 100 kg)	\$ 52.00 per tonne
Soil/ Fill (200 Kg or less) Minimum (top soil, sand, sod, asphalt, masonry, concrete without rebar)	\$ 5.40 per load
Soil/ Fill (greater than 200 Kg) Minimum (top soil, sand, sod, asphalt, masonry, concrete without rebar)	\$ 27.00 per tonne
Asbestos (250 Kg or less flat rate) minimum	\$119.00 per load
Asbestos (greater than 250 Kg)	\$476.00 per tonne
Woodchips (200 kg or less) minimum	\$5.40
Woodchips	\$ 27.00 per tonne

6. The fees related to the Solid Waste Diversion Program at the Trail Waste Facility are as follows:

Municipal Compost minimum (200 kg or less)	\$ 7.80
Municipal Compost (greater than 200 kg)	\$ 39.00
