BY-LAW NO. 2017 - 77

A by-law of the City of Ottawa to establish certain lands as common and public highway and assume it for public use (Bayview Road).

WHEREAS the Council of the City of Ottawa deems it appropriate to establish as common and public highway and assume for public use certain lands in the City of Ottawa;

AND WHEREAS Section 31 of the Municipal Act, 2001, S.O. 2001, c.25, empowers a municipality to pass a by-law for establishing and laying out highways;

AND WHEREAS in accordance with subsection 5(2) of the City of Ottawa Act, 1999 being Schedule E to the Fewer Municipal Politicians Act, 1999, c. 14, S.O. 1999, the City of Ottawa stands in the place of the old municipalities as defined under the Act for all purposes;

THEREFORE the City of Ottawa enacts as follows:

1. The following lands are hereby established as common and public highways and assumed for public use:

- (1) (Bayview Road)
Part of Lots 7, 8, 9, 10, 11 and 12, Block 5, Registered Plan 73; Part of Alonzo Street, Registered Plan 73, as closed by By-law 3121, registered as Instrument Number CR103746; Part of Lots 6 and 7, South Alonzo Street, Block 4, Registered Plan 73, City of Ottawa designated as Part 6 on Plan 4R-29952.
- (2) (Bayview Road)
Part of Lots 5 and 6, East Bayview Road, Block 4, Registered Plan 73, City of Ottawa designated as Part 7 on Plan 4R-29952.
- (3) (Bayview Road)
Part of Lot 6, East Bayview Road, Block 4, Registered Plan 73, City of Ottawa designated as Part 10 on Plan 4R-29952.

2. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
