BY-LAW NO. 2017 - 84

A by-law of the City of Ottawa to amend By-law No. 2008-250 of the City of Ottawa to change the zoning of part of the lands known municipally as 300 Goulbourn Forced Road.

The Council of the City of Ottawa, pursuant to Section 34 of the *Planning Act*, R.S.O.1990, enacts as follows:

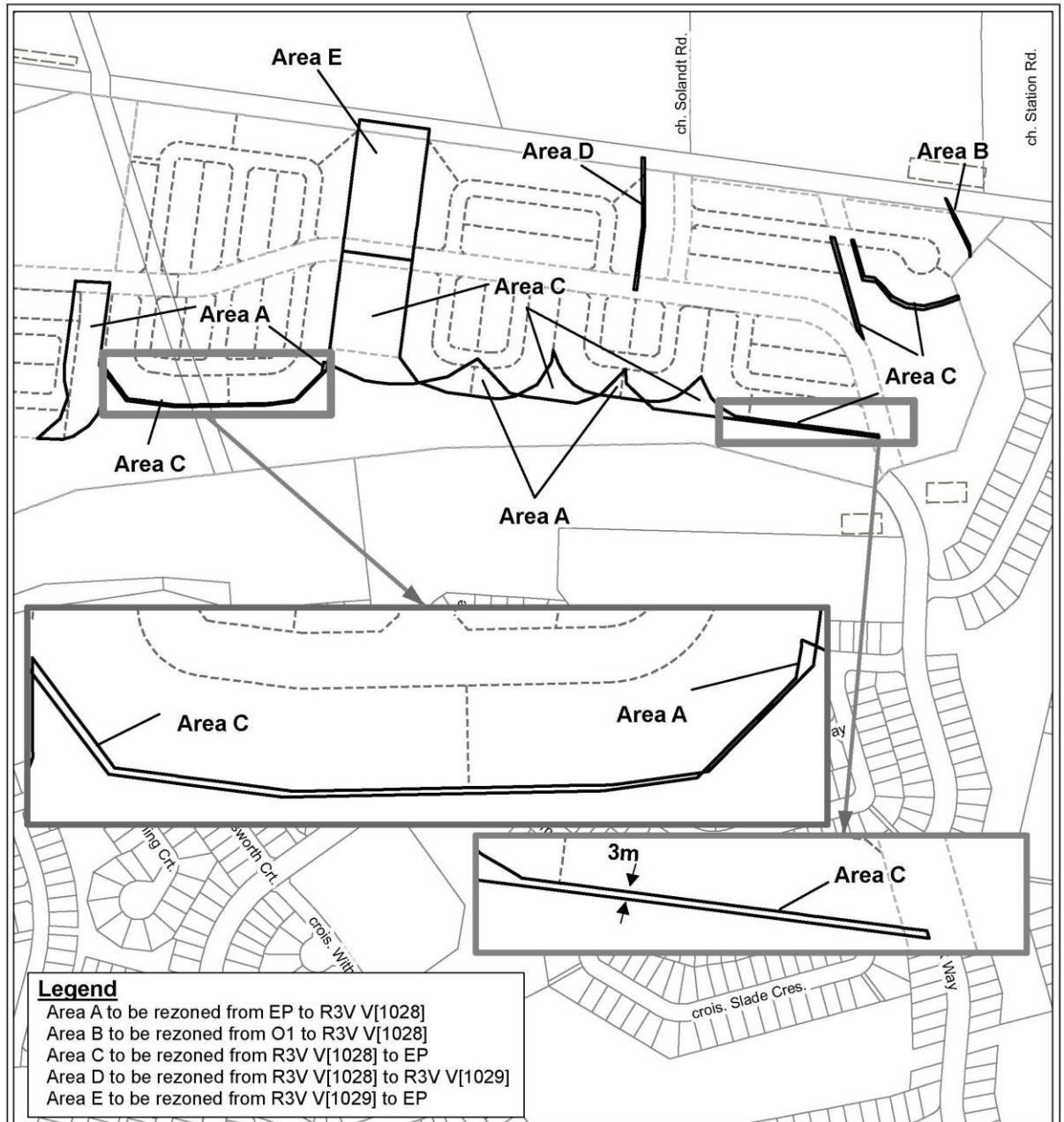
1. The Zoning Map of By-law No. 2008-250, entitled the "City of Ottawa Zoning By-law" is amended by rezoning the lands shown on Attachment 1 to this by-law as follows:

- (a) Area A from EP to R3VV[1028];
- (b) Area B from O1 to R3VV[1028];
- (c) Area C from R3VV[1028] to EP;
- (d) Area D to from R3VV[1028] to R3VV[1029]; and,
- (e) Area E to from R3VV[1029] to EP.
