BY-LAW NO. 2017 - 96

A by-law of the City of Ottawa to change the name of avenue Kilborn Avenue, cour Sellers Court, voie Casson Way, avenue Beauchamp Avenue and a portion of avenue Billings Avenue, municipal highways in the City of Ottawa.

WHEREAS the Council of the City of Ottawa desires to assign a new name to certain municipal highways in the City of Ottawa;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. That "avenue Kilborn Avenue" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Lamira Street".
2. That "cour Sellers Court" in the City of Ottawa, described in Schedule "A" shall be assigned the name "cour Smugglers Court".
3. That "voie Casson Way" in the City of Ottawa, described in Schedule "A" shall be assigned the name "voie Alfred Casson Way".
4. That "avenue Beauchamp Avenue" in the City of Ottawa, described in Schedule "A" shall be assigned the name "voie Scott-Dupuis Way".
5. That "avenue Billings Avenue" in the City of Ottawa, described in Schedule "A" shall be assigned the name "place Sarah Billings Place".
6. That Schedule "A" form part of this by-law.
7. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
