BY-LAW NO. 2017- 137

A by-law of the City of Ottawa to amend By-law No. 2001-3 entitled "A by-law of the City of Ottawa to appoint a Deputy Chief Building Official for the City of Ottawa".

WHEREAS, in accordance with Section 21 of the City of Ottawa Act, 1999, S.O. 1999, Chap. 14, Schedule E, the Council of the City of Ottawa is deemed to have taken all steps required to appoint John Buck to the office of the Manager of Building Inspection & Enforcement in Building Services Branch in the Department of Development Services for the City of Ottawa;

AND WHEREAS Section 3(1) of the Building Code Act, 1992, S.O. 1992, Chap. 23 provides that the Council is responsible for the enforcement of the said Act in the City;

AND WHEREAS Section 3(2) of the said Building Code Act, 1992 provides that the Council shall appoint a Chief Building Official;

AND WHEREAS pursuant to Section 77(b) of the Legislation Act 2006, S.O. 2006, Chap. 21, Schedule F, as amended, the Council is empowered to appoint a Deputy Chief Building Official;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. Section 1 of By-law No. 2001 - 3 entitled "A by-law of the City of Ottawa to appoint a Deputy Chief Building Official for the City of Ottawa" is amended by adding the following person:

John BUCK

and striking out the following person:

Matthew GRAHAM

2. This by-law shall be deemed to have come into force and effect on April 28, 2017.
