BY-LAW NO. 2017 - 154

A by-law of the City of Ottawa to amend By-law No. 2008-250 of the City of Ottawa to change the zoning of part of the lands known municipally as 1170 March Road and 1156 March Road.

The Council of the City of Ottawa, pursuant to Section 34 of the *Planning Act*, R.S.O.1990, enacts as follows:

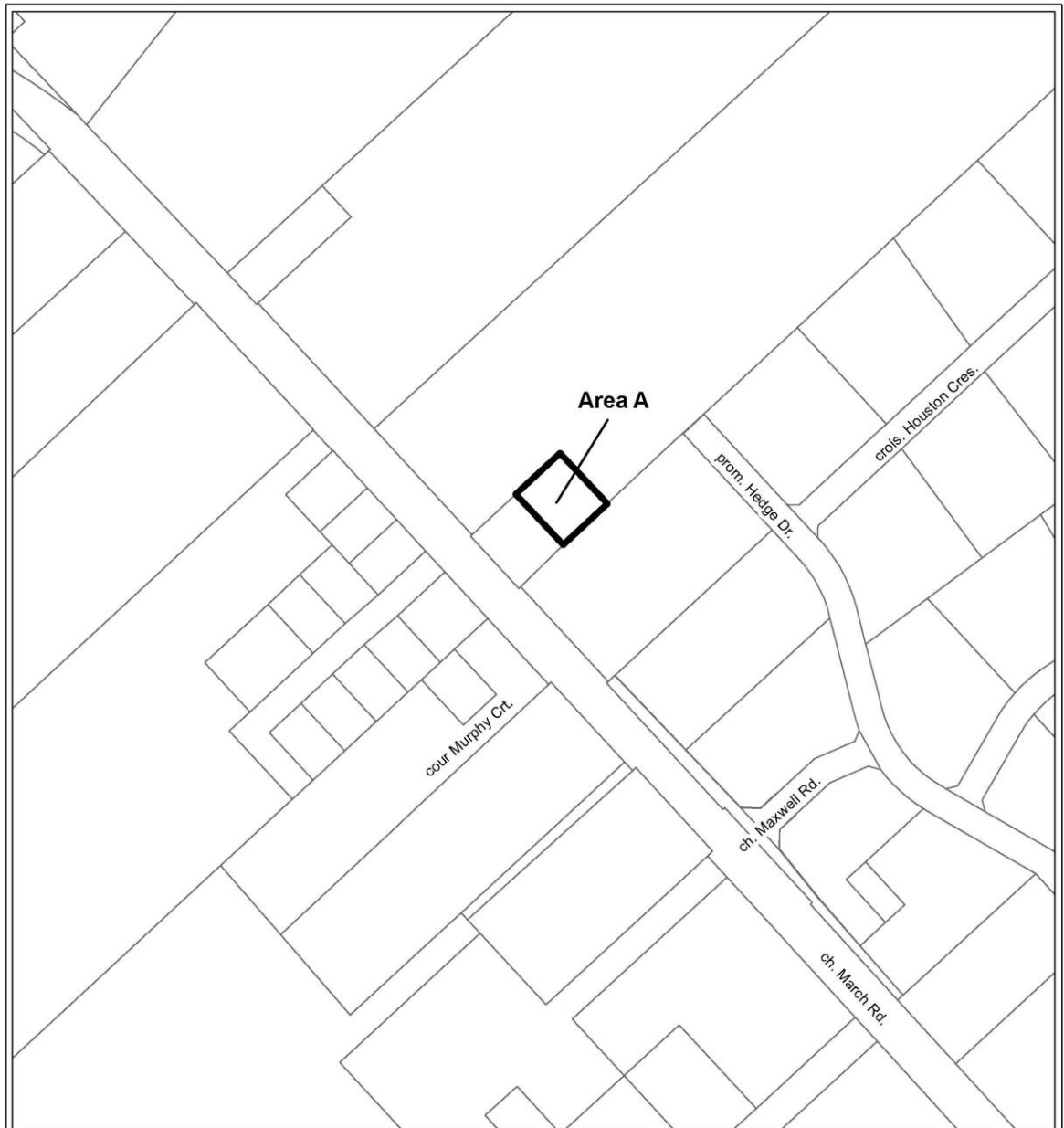
1. The Zoning Map of By-law No. 2008-250, entitled the "City of Ottawa Zoning By-law" is amended by rezoning the lands shown as Area A on Attachment 1 to this by-law from RU to RC2[467r].
2. Exception 467r of Section 240 – Rural Exceptions of the said By-law No. 2008-250 is amended by replacing all of the text in Column IV with the following:

"All uses except for:
- convenience store
- gas bar"
