BY-LAW NO. 2017 – 164

A by-law of the City of Ottawa to amend By-law No. 2003-514 respecting fees for sewer use.

The Council of the City of Ottawa enacts as follows:

1. Schedule “B”, Fees, of By-law No. 2003-514 entitled “A by-law of the City of Ottawa to regulate the control of discharges to sewers and sewage works”, as amended, is repealed and Schedule “B”, Fees attached hereto is substituted therefor.
2. This by-law comes into force and takes effect on May 1, 2017.
