The Council of the City of Ottawa enacts as follows:

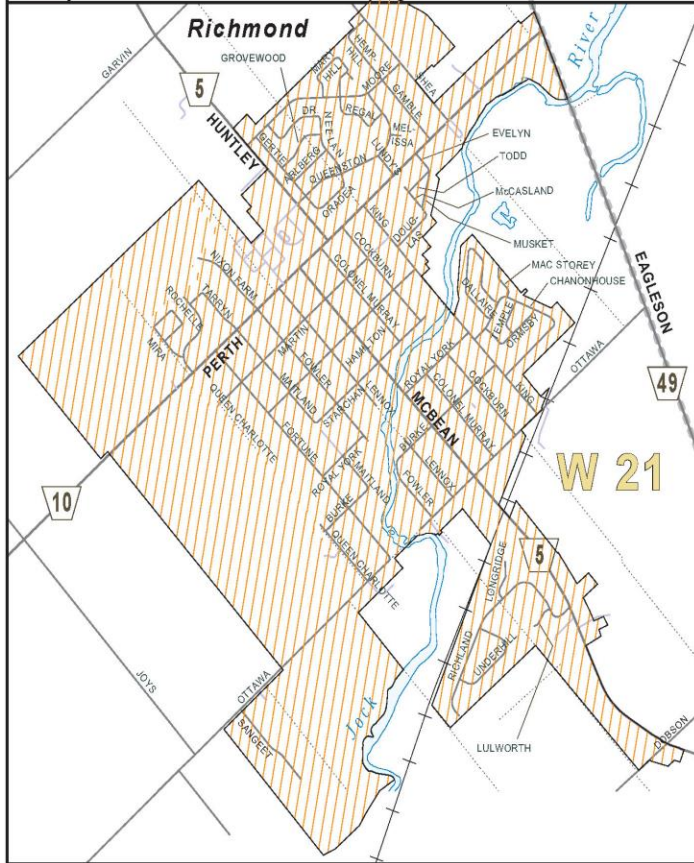

ENACTED AND PASSED this 28th day of June 2017.

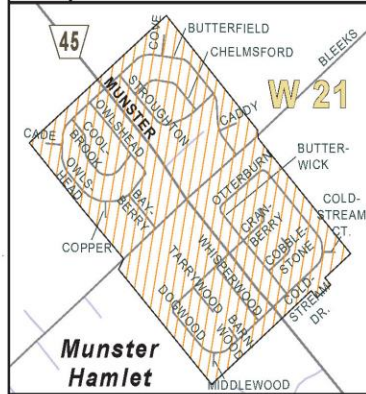

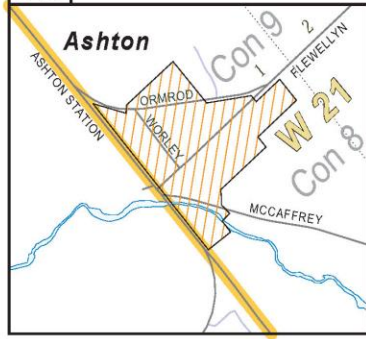
