BY-LAW NO. 2017 - 214

A by-law of the City of Ottawa to amend By-law No. 2017-92 respecting the regulation of Right of Way patios on City highways.

WHEREAS at its meeting of June 14th, 2017, by way of Motion 22, Council established new lower insurance requirements for café seating patios;

AND WHEREAS By-law No. 2017 – 212 confirms the proceedings of Council of June 14th, 2017;

NOW THEREFORE Council of the City of Ottawa enacts as follows:

1. Repeal Section 13 (a), “INSURANCE” of By-law No. 2017-92 entitled “A by-law of the City of Ottawa to regulate Right of Way patios on City highways” and replace it with the following Section 13 (a):

INSURANCE

13. The permit holder applicant shall provide and maintain insurance in accordance with the following requirements in respect of each ROW patio permit issued to the permit holder under this by-law:

- (a) Commercial General Liability insurance subject to limits of not less than \$5,000,000 inclusive per occurrence or not less than \$2,000,000 inclusive per occurrence for Café seating patios only, for bodily injury, death and damage to property including loss of use thereof, and such insurance shall be in the name of the applicant and shall name the City as an additional insured thereunder and which shall preclude subrogation claims by the Insurer against anyone insured thereunder;

2. This by-law shall come into force and take effect on June 28th, 2017.

ENACTED AND PASSED this 28th day of June, 2017.
