BY-LAW NO. 2017 - 225

A by-law of the City of Ottawa to establish certain lands as common and public highway and assume them for public use (Gordon Murdock Road, Old Stagecoach Road, Pana Road, 9<sup>th</sup> Line Road, Mackey Road, McCordick Road, Mutual Street, Roger Stevens Drive, Farmer's Way, Beckett's Creek Road, Carp Road, Innes Road, Riverside Drive, McGee Side Road, Cowell Road).

WHEREAS the Council of the City of Ottawa deems it appropriate to establish as common and public highway and assume for public use certain lands in the City of Ottawa;

AND WHEREAS Section 31 of the Municipal Act, 2001, S.O. 2001, c.25, empowers a municipality to pass a by-law for establishing and laying out highways;

AND WHEREAS in accordance with subsection 5(2) of the City of Ottawa Act, 1999 being Schedule E to the Fewer Municipal Politicians Act, 1999, c. 14, S.O. 1999, the City of Ottawa stands in the place of the old municipalities as defined under the Act for all purposes;

THEREFORE the City of Ottawa enacts as follows:

1. The following lands are hereby established as common and public highway and assumed for public use:

- (1) (Gordon Murdock Road)  
Part of Lot 34, Concession 2, Osgoode, designated as Part 1 on Plan 4R-30218, City of Ottawa.
- (2) (Old Stagecoach Road)  
Part of Lot 34, Concession 2, Osgoode, designated as Part 3 on Plan 4R-30218, City of Ottawa.
- (3) (Pana Road)  
Part of Lot 15, Concession 8, Osgoode, designated as Part 3 on Plan 4R-29861, City of Ottawa.
- (4) (9<sup>th</sup> Line Road)  
Part of Lot 15, Concession 8, Osgoode, designated as Part 4 on Plan 4R-29861, City of Ottawa.
- (5) (Mackey Road)  
Part of Lot 1, Concession 3, Marlborough, designated as Part 2 on Plan 4R-30166, City of Ottawa.
- (6) (McCordick Road)  
Part of Lot 1, Concession 3, Marlborough, designated as Part 3 on Plan 4R-30166, City of Ottawa.

- (7) (Mutual Street)  
Part of Lot 122, Plan 300, designated as Part 4 on Plan 4R-30187, City of Ottawa.
- (8) (Mackey Road)  
Part of Lot 3, Concession 3, Marlborough, designated as Part 2 on Plan 4R-30158, City of Ottawa.
- (9) (Roger Stevens Drive)  
Part of Lot 9, Concession 5, Marlborough, designated as Part 1, on Plan 4R-30011, City of Ottawa.
- (10) (Farmer's Way)  
Part of Lot 10, Concession 8 O.F. Gloucester, designated as Part 2 on Plan 4R-29970, City of Ottawa.
- (11) (Beckett's Creek Road)  
Part of Lot 5, Concession 2 O.S., Cumberland, designated as Part 3 on Plan 4R-29761, City of Ottawa.
- (12) (Carp Road)  
Part of Lot 10, Concession 2, Huntley, designated as Parts 1 and 2 on Plan 4R-30179, City of Ottawa.
- (13) (Innes Road)  
Part of Lot 4, Concession 3, (Ottawa Front), Gloucester, designated as Parts 2, 4, 5 and 7 on Expropriation Plan OC339341, City of Ottawa.
- (14) (Riverside Drive)  
Part of Lot 1, Concession 2 R.F., Gloucester, designated as Part 1 on Plan 4R-30292, City of Ottawa.
- (15) (Roger Stevens Drive)  
Part of Lot 8, Concession 6, Marlborough designated as Part 5 on Plan 4R-29980, City of Ottawa.
- (16) (McGee Side Road)  
Part of Lot 11, Concession 3, Huntley, designated as Parts 8, 12 and 13 on Plan 4R-28547, City of Ottawa.
- (17) (Carp Road)  
Part of Lot 11, Concession 3, Huntley, designated as Parts 9, 10 and 11 on Plan 4R-28547, City of Ottawa.
- (18) (Cowell Road)  
Part of Lot 5, Concession 3, Marlborough designated as Parts 3 and 4 on Plan 4R-30138, City of Ottawa.

2. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
