BY-LAW NO. 2017 – 253

A by-law of the City of Ottawa to amend By-law No. 2008-449 to provide for valet parking tourist services license in the ByWard Market.

The Council of the City of Ottawa enacts as follows:

1. By-law No. 2008-449 entitled “A by-law of the City of Ottawa respecting the licensing, regulating and governing of vending and performance activities, and the provision of tourist services, in the ByWard Market and the establishment of a designated space programme for the ByWard Market”, as amended, is amended by repealing the definition of “Tourist Services” in section 1 and substituting the following therefore:

“tourist services” includes tourist information services, bicycle rental services, tour bus services, walking tour services, rickshaw tour services and valet parking services;

2. Schedule “FS” of By-law No. 2008-449 entitled “A by-law of the City of Ottawa respecting the licensing, regulating and governing of vending and performance activities, and the provision of tourist services, in the ByWard Market and the establishment of a designated space programme for the ByWard Market”, as amended, is amended by adding under the heading “Stand Permit Fees:” the following therefore:

Monthly Stand Permit Fees for valet parking services will be \$200.00 per month and shall be subject to the payment of a license fee in the amount of \$150.00. “Tourist Services” licenses for valet parking services and associated stand permits shall be administered by the Markets Manager and subject to terms and conditions as determined by the Markets Manager.

3. This by-law shall come into force on the 28th day of June, 2017.
