BY-LAW NO. 2017 - 263

A by-law of the City of Ottawa to establish certain lands as common and public highway and assume them for public use (Walter Bradley Road, Dunrobin Road, Rideau Valley Drive South, Sunderland Street, West Hunt Club Road, Place d'Orleans Drive, St. Joseph Boulevard, Kirkwood Avenue, Bank Street, Benjamin Avenue, chemin Forced Road).

WHEREAS the Council of the City of Ottawa deems it appropriate to establish as common and public highway and assume for public use certain lands in the City of Ottawa;

AND WHEREAS Section 31 of the Municipal Act, 2001, S.O. 2001, c.25, empowers a municipality to pass a by-law for establishing and laying out highways;

AND WHEREAS in accordance with subsection 5(2) of the City of Ottawa Act, 1999 being Schedule E to the Fewer Municipal Politicians Act, 1999, c. 14, S.O. 1999, the City of Ottawa stands in the place of the old municipalities as defined under the Act for all purposes;

THEREFORE the City of Ottawa enacts as follows:

1. The following lands are hereby established as common and public highway and assumed for public use:

- (1) (Walter Bradley Road)
Part of Lot 14, Concession 1, Fitzroy, designated as Part 2 on Plan 4R-30235, City of Ottawa.
- (2) (Dunrobin Road)
Part of the South Half of Lot 25, Concession 3, March, designated as Part 1 on Plan 5R-2844, City of Ottawa.
- (3) (Rideau Valley Drive South`)
Part of Lot 25, Concession 1, North Gower, designated as Part 2 on Plan 4R-30268, City of Ottawa.
- (4) (Sunderland Street)
Part of Lot 28, Concession A, Rideau Front, Nepean, designated as Parts 9, 12 and 14 on Plan 4R-29938, City of Ottawa.
- (5) (West Hunt Club Road)
Part of Lot 28, Concession A, Rideau Front, Nepean, designated as Parts 3, 4 and 5 on Plan 4R-29938, City of Ottawa.
- (6) (Place d'Orleans Drive)
Part of West Common, Concession 1 (Old Survey) Cumberland, designated as Parts 1 and 2 on Plan 4R-30177, City of Ottawa.

- (7) (St. Joseph Boulevard)
Part of Lot 7, Plan 86, designated as Part 5 on Plan 4R-10981, City of Ottawa.
- (8) (Kirkwood Avenue)
Part of Block I, Plan 186, designated as Part 1 on Plan 4R-29979, City of Ottawa.
- (9) (Bank Street)
Part of Lot 1, Plan 47389, designated as Parts 1 and 2 on Plan 4R-30243, City of Ottawa.
- (10) (Benjamin Avenue)
Part of Lot 26, Concession 2 Ottawa Front, Nepean, designated as Part 6 on Plan 4R-29813, City of Ottawa.
- (11) (chemin Forced Road)
Part of Lot 21, Concession 5, Cumberland, designated as Part 2 on Plan 4R-30035, City of Ottawa.

2. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
