The Council of the City of Ottawa, pursuant to section 38 of the *Planning Act*, R.S.O.1990, c. P.13, the Council of the Corporation is entitled to establish interim control in any defined area or areas in the municipality;

WHEREAS on September 13th, 2017, Council carried a motion to repeal By-law 2017-245 as it applies to the lands municipally known as 220 Sunnyside Avenue and 45 Drouin Avenue;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. By-law 2017-245, entitled, "A by-law of the City of Ottawa to establish interim control for lands within Sandy Hill, and portions of Old Ottawa East and Overbrook." is repealed for the lands municipally known as 220 Sunnyside Avenue and 45 Drouin Avenue.
