BY-LAW NO. 2017 - 310

A by-law of the City of Ottawa to designate certain lands at Yellowstone Court and Barry Helman Crescent on Plan 4M-1513 as being exempt from Part Lot Control.

WHEREAS the *Planning Act*, R.S.O. 1990, c.P.13, as amended, (the "*Planning Act*") subsection 50(5) provides that all lands within a plan of subdivision are subject to part lot control;

AND WHEREAS authority is vested in Council by the *Planning Act*, subsection 50(7) to enact by-laws which provide that subsection 50(5) does not apply to such lands as are designated in the by-law;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. Subject to Section 2 hereof, the *Planning Act*, subsection 50(5) does not apply to the land described as:
 - (a) Part of Lots 132 and 133 on Plan 4M-1513, designated as Part 16 on Plan 4R-28984;
 - (b) Part of Lots 133 and 134 on Plan 4M-1513, designated as Parts 17, 18 and 19 on Plan 4R-28984;
 - (c) Part of Lots 154 and 155 on Plan 4M-1513, designated as Parts 34, 35 and 36 on Plan 4R-28984;
 - (d) Part of Lots 155 and 156 on Plan 4M-1513, designated as Parts 37, 38, 39, 40 and 41 on Plan 4R-28984;
 - (e) Part of Lots 156 and 157 on Plan 4M-1513, designated as Parts 42 and 43 on Plan 4R-28984;
 - (f) Part of Lots 157 and 158 on Plan 4M-1513, designated as Part 44 on Plan 4R-28984;
 - (g) Part of Lots 158 and 159 on Plan 4M-1513, designated as Plans 45, 46 and 47 on Plan 4R-28984; and
 - (h) Part of Lots 159 and 160 on Plan 4M-1513, designated as Parts 48, 49 and 50 on Plan 4R-28984, in the City of Ottawa
2. This by-law shall be effective only to the extent necessary to permit:
 - (a) the creation of parcels for construction purposes and to permit such parcels to be charged and/or discharged;
 - (b) individual dwelling units, together with appurtenant rights and easements in land associated therewith, to be conveyed to each initial purchaser thereof, and to be charged and discharged; and
 - (c) any easements, including rights-of-way, as contained in the transfers to each initial purchaser of each individual dwelling unit;and this by-law shall not be construed as to permit the further severance or resubdivision of any such parcel.
3. A conveyance or conveyances in favour of the City of Ottawa shall not for the purpose of this by-law be considered to be a severance and this by-law shall also be

deemed to permit the grant or release of easements held in favour of the City on or with respect to the lands described above.

4. Registration of a certified copy of this by-law in the proper land registry office is authorized and this by-law shall thereupon become effective.

5. This by-law shall expire and be of no further force and effect as of the 27th day of September, 2019.
