BY-LAW NO. 2017 - 335

A by-law of the City of Ottawa to change the name of avenue Moore Avenue, street Triole Street, place Palmer Place, avenue Jackson Avenue, rue King Street; chemin Cambrian Road, rue Queen Charlotte Street, rue Royal York Street, rue Fowler Street, rue Maitland Street, rue Colonel Murray Street, rue Henley Street, place Bronson Place, municipal highways in the City of Ottawa.

WHEREAS the Council of the City of Ottawa desires to assign a new name to certain municipal highways in the City of Ottawa;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. That "avenue Moore Avenue" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Judge Street".
2. That "street Triole Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "way Lagan Way".
3. That "place Palmer Place" in the City of Ottawa, described in Schedule "A" shall be assigned the name "place Verger Place".
4. That "avenue Jackson Avenue" in the City of Ottawa, described in Schedule "A" shall be assigned the name "avenue Charles Jackson Avenue".
5. That "rue King Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue King Street North/Nord".
6. That "chemin Cambrian Road" in the City of Ottawa, described in Schedule "A" shall be assigned the name "chemin Cambrian Road West/Ouest".
7. That "rue Queen Charlotte Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Queen Charlotte Street North/Nord".
8. That "rue Royal York Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Royal York Street West/Ouest".
9. That "rue Fowler Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Fowler Street South/Sud".
10. That "rue Maitland Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Maitland Street South/Sud".
11. That "rue Colonel Murray Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Colonel Murray Street South/Sud".

12. That "rue Henley Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Stuart Kettles Street".

13. That "place Bronson Place" in the City of Ottawa, described in Schedule "A" shall be assigned the name "terrace Canal Woods Terrace".

14. That Schedule "A" form part of this by-law.

15. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
