A by-law of the City of Ottawa to designate certain lands at voie Axis Way on Plan 4M-1544 and croissant Rainrock Crescent, voie Wild Calla Way, cours Dragonfly Walk, rue Compass Street, voie Featherfoil Way and croissant Shinleaf Crescent on Plan 4M- 1545, as being exempt from Part Lot Control.

BY-LAW NO. 2017 - 366

A by-law of the City of Ottawa to designate certain lands at voie Axis Way on Plan 4M-1544 and croissant Rainrock Crescent, voie Wild Calla Way, cours Dragonfly Walk, rue Compass Street, voie Featherfoil Way and croissant Shinleaf Crescent on Plan 4M-1545, as being exempt from Part Lot Control.

WHEREAS the *Planning Act*, R.S.O. 1990, c.P.13, as amended, (the "*Planning Act*") subsection 50(5) provides that all lands within a plan of subdivision are subject to part lot control;

AND WHEREAS authority is vested in Council by the *Planning Act*, subsection 50(7) to enact by-laws which provide that subsection 50(5) does not apply to such lands as are designated in the by-law;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. Subject to Section 2 hereof, the *Planning Act*, subsection 50(5) does not apply to the land described as:

- (a) Blocks 84, 85, 87 to 97 inclusive on Plan 4M-1545;
- (b) Part of Block 72 on Plan 4M-1545, designated as Parts 19 and 20 on Plan 4R-29664;
- (c) Part of Block 77 on Plan 4M-1545, designated as Parts 5 to 8 inclusive on Plan 4R-30065;
- (d) Part of Block 78 on Plan 4M-1545, designated as Parts 3 to 8 inclusive on Plan 4R-29933;
- (e) Part of Block 80 on Plan 4M-1545, designated as Parts 7 to 13 inclusive on Plan 4R-29481;
- (f) Part of Block 81 on Plan 4M-1545, designated as Parts 10 to 15 inclusive and Parts 18 to 21 inclusive on Plan 4R-30484;
- (g) Part of Block 82 on Plan 4M-1545, designated as Parts 3 and 4 on Plan 4R-30372;
- (h) Part of Block 83 on Plan 4M-1545, designated as Parts 9 and 10 on Plan 4R-30517;
- (i) Part of Block 86 on Plan 4M-1545, designated as Parts 1 to 7 inclusive on Plan 4R-30484;
- (j) Part of Block 98 on Plan 4M-1545, designated as Parts 1, 2, 5, 7, 9, 11 and 12 on Plan 4R-30523;

- (k) Part of Block 99 on Plan 4M-1545, designated as Parts 7 and 9 on Plan 4R-29627;
- (l) Part of Block 100 on Plan 4M-1545, designated as Parts 3 and 6 on Plan 4R-30055; and
- (m) Blocks 137 and 138 on Plan 4M-1544, in the City of Ottawa.

2. This by-law shall be effective only to the extent necessary to permit:

- (a) the creation of parcels for construction purposes and to permit such parcels to be charged and/or discharged;
- (b) individual dwelling units, together with appurtenant rights and easements in land associated therewith, to be conveyed to each initial purchaser thereof, and to be charged and discharged; and
- (c) any easements, including rights-of-way, as contained in the transfers to each initial purchaser of each individual dwelling unit;

and this by-law shall not be construed as to permit the further severance or resubdivision of any such parcel.

3. A conveyance or conveyances in favour of the City of Ottawa shall not for the purpose of this by-law be considered to be a severance and this by-law shall also be deemed to permit the grant or release of easements held in favour of the City on or with respect to the lands described above.

4. Registration of a certified copy of this by-law in the proper land registry office is authorized and this by-law shall thereupon become effective.

5. This by-law shall expire and be of no further force and effect as of the 22nd day of November, 2019.
