BY-LAW NO. 2017 – 376

A by-law of the City of Ottawa to amend By-law No. 2004-239 regulating the placement of temporary signs on private property.

The Council of the City of Ottawa hereby enacts as follows:

1. The definition "election sign" in Section 1 of By-law No. 2004-239 entitled "A b-law of the City of Ottawa regulating the placement of temporary signs on private property", is repealed and the following definition is substituted in its place:

"election sign" means a temporary sign that supports or opposes a candidate, a political party, or a "yes" or "no" answer to a question on the ballot in a municipal, school board, public utility company, provincial or federal election:

2. Section 21 of said By-Law No. 2004-239 is repealed and the following section is substituted in its place:

ELECTION SIGNS

- (1) No person or entity shall place or cause to be placed or allow to remain placed an election sign more than sixty (60) days immediately preceding the election date.
- (2) Every election sign together with its appurtenances shall be removed from the premise within forty-eight (48) hours following the election date.
