BY-LAW NO. 2017 - 377

A by-law of the City of Ottawa to amend By-law No. 2003-520 to regulate signs and advertising devices on City roads.

The Council of the City of Ottawa hereby enacts as follows:

1. The definition "election sign" in Section 1 of By-law No. 2003-520 entitled "A b-law of the City of Ottawa to regulate signs and advertising devices on City roads", is repealed and the following definition is substituted in its place:

"election sign" means a temporary sign, including a poster sign or rigid ground mounted sign, advertising support or opposition for a candidate, a political party, or a "yes" or "no" answer to a question on the ballot in a municipal, school board, public utility company, provincial or federal election, and in the case of rigid ground-mounted sign, having a sign face not greater than four hundred and sixty millimeters (460 mm) in width and seven hundred and sixty millimeters (760 mm) in height, and the upper extremity of which is not greater than one hundred and twenty centimeters (120 cm) from the ground;
