BY-LAW NO. 2017 - 390

A by-law of the City of Ottawa to establish certain lands as common and public highway and assume it for public use (Lynn Valley Terrace).

WHEREAS the Council of the City of Ottawa deems it appropriate to establish as common and public highway and assume for public use certain lands in the City of Ottawa;

AND WHEREAS Section 31 of the Municipal Act, 2001, S.O. 2001, c.25, empowers a municipality to pass a by-law for establishing and laying out highways;

AND WHEREAS in accordance with subsection 5(2) of the City of Ottawa Act, 1999 being Schedule E to the Fewer Municipal Politicians Act, 1999, c. 14, S.O. 1999, the City of Ottawa stands in the place of the old municipalities as defined under the Act for all purposes;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. The following lands are hereby established as common and public highways and assumed for public use:

a) Part of Block 142, 143, 155 and 156 on Registered Plan 4M-1544 designated as Part 24 on Plan 4R-30469, City of Ottawa (Lynn Valley Terrace).

2. This by-law shall come into force and take effect when all of the above-noted lands in Section 1 are owned by the City of Ottawa and the by-law has subsequently been registered in the Land Registry Division of Ottawa-Carleton.
