BY-LAW NO. 2017 - 400

A by-law of the City of Ottawa to amend and extend By-law No. 2013-199 respecting the temporary regulation of the operation of All-Terrain Vehicles and Motorized Snow Vehicles on certain designated highways and unopened road allowances within Osgood Ward (Ward 20) in the City of Ottawa.

The Council of the City of Ottawa enacts as follows:

1. Section 24 of By-law 2013-199 entitled “A by-law of the City of Ottawa to temporarily regulate the operation of All-Terrain Vehicles and Motorized Snow Vehicles on certain designated highways and unopened road allowances within Osgood Ward (Ward 20) in the City of Ottawa” as amended, is further amended by striking out the words “November 30, 2017” and substituting with the words “January 31, 2019” in their place.
