BY-LAW NO. 2017 - 417

A by-law of the City of Ottawa to confirm proceedings of the Council of the City of Ottawa at its meeting held on December 13, 2017.

WHEREAS subsection 5(1) of the *Municipal Act, 2001*, S.O. 2001, Chapter 25, as amended, provides that the powers of a municipal corporation are to be exercised by its council;

AND WHEREAS subsection 5(3) of the said *Municipal Act* provides that the powers of every council are to be exercised by by-law;

AND WHEREAS it is deemed expedient that the proceedings of the Council of the City of Ottawa at this meeting be confirmed and adopted by by-law;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. The action of the Council of the City of Ottawa in respect of each recommendation contained in the report from the Deputy City Treasurer entitled "2018 Draft Operating and Capital Budgets"; the report from the Committee of Adjustment entitled "2018 Draft Operating Estimates – Committee of Adjustment"; the report from Crime Prevention Ottawa entitled "Crime Prevention Ottawa 2018 Draft Budget"; the report from the Ottawa Police Services Board entitled "Ottawa Police Service 2018 Draft Operating and Capital Budgets"; the report from the Ottawa Public Library Board entitled "Ottawa Public Library: Approval of the 2018 Draft Budget Estimates"; the report from the Ottawa Board of Health entitled "2018 Draft Operating Budget for the Ottawa Board of Health"; Agriculture and Rural Affairs Committee Report 30; Audit Committee Report 14, Community and Protective Services Committee Report 28; Environment and Climate Protection Committee Report 17; Finance and Economic Development Committee Report 30; Information Technology Sub-Committee Report 4; Planning Committee Reports 55 and 56, Transit Commission Report 16; Transportation Committee Report 29; 1. the report from the City Clerk and Solicitor's Office entitled "Planning Advisory Committee – Establishment"; the report from the City Clerk and Solicitor's Office entitled "Status Update – Council Inquiries and Motions for the Period Ending December 8, 2017"; and the report from the City Clerk and Solicitor's Office entitled "Summary of Oral And Written Public Submissions for Items Subject to Bill 73 'Explanation Requirements' at the City Council Meeting of 22 November 2017 "be received and adopted as amended, and any reports of committees and of local boards and commissions and each motion and resolution passed and other action taken by the Council of the City of Ottawa at this meeting is hereby adopted and confirmed as if all such proceedings were expressly embodied in this by-law.
2. The Mayor and the appropriate officials of the City of Ottawa are hereby authorized and directed to do all things necessary to give effect to the action of the Council of the City of Ottawa referred to in the preceding section.

3. The Mayor, or in the absence of the Mayor, the Deputy Mayor and the City Clerk, or in the absence of the City Clerk, the Deputy City Clerk, or in the absence of the City Clerk and the Deputy City Clerk, the Acting City Clerk are authorized and directed to execute all documents necessary in that behalf and to affix thereto the corporate seal of the City of Ottawa.
