BY-LAW NO. 2018 - 30

A by-law of the City of Ottawa to establish certain lands as common and public highway and assume them for public use (Carling Avenue, March Road, Brigade Avenue, Montreal Road, Broadview Avenue, Kirkwood Avenue, Stittsville Main Street, McLinton Road, Hazeldean Road).

WHEREAS the Council of the City of Ottawa deems it appropriate to establish as common and public highway and assume for public use certain lands in the City of Ottawa;

AND WHEREAS Section 31 of the Municipal Act, 2001, S.O. 2001, c.25, empowers a municipality to pass a by-law for establishing and laying out highways;

AND WHEREAS in accordance with subsection 5(2) of the City of Ottawa Act, 1999 being Schedule E to the Fewer Municipal Politicians Act, 1999, c. 14, S.O. 1999, the City of Ottawa stands in the place of the old municipalities as defined under the Act for all purposes;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. The following lands are hereby established as common and public highway and assumed for public use:

- (1) (Carling Avenue)
Part of Lot 33, Plan 311; Part of Lot 35, 36, 43 and 44 on Plan 348 designated as Part 1 on Plan 4R-30726, City of Ottawa.
- (2) (March Road)
Part of Block 3, Plan 4M-417, designated as Parts 1, 3, 5, 6, 8, 9, 11 and 12 on Plan 4R-30377, City of Ottawa.
- (3) (Brigade Avenue)
Part of Lot 5, Plan 655, designated as Part 3 on Plan 4R-30667, City of Ottawa.
- (4) (Montreal Road)
Part of Lots A, 1 and 1, Plan 142, E/S Brunel Street (formerly Mary Street), W/S Foxview Place (formerly Ann Street) and N/S Montreal Road respectively, designated as Part 1 on Expropriation Plan NS153361, City of Ottawa.
- (5) (Broadview Avenue)
Part of Lot 178, Plan 283, designated as Part 1 on Plan 4R-30365, City of Ottawa.
- (6) (Kirkwood Avenue)
Part of Lot 15, Plan 152, designated as Parts 3 and 4 on Plan 4R-30452, City of Ottawa.

- (7) (Stittsville Main Street)
Part of Lot 24, Concession 11 Goulbourn, designated as Part 3 on Plan 4R-30305, City of Ottawa.
- (8) (McLinton Road)
Part of Lot 2, Concession 7, Goulbourn, designated as Part 2 on Plan 4R-30237 City of Ottawa.
- (9) (Hazeldean Road)
Part of Lot 25, Concession 12, Goulbourn, designated as Part 1, on Plan 4R-24351, City of Ottawa.

2. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
