BY-LAW NO. 2018- 41

A by-law of the City of Ottawa to amend By-law No. 2008-250 of the City of Ottawa to remove the holding symbol from part of the lands municipally known as 2840 Stagecoach Road.

The Council of the City of Ottawa, pursuant to Section 34 of the *Planning Act*, R.S.O.1990, enacts as follows:

1. The Zoning Map of By-law No. 2008-250, entitled the “City of Ottawa Zoning By-law” is amended by removing the “-h” symbol from the lands shown as Area A on Attachment 1 to this by-law, such that the lands are zoned from ME3[1r]-h to ME3.
