BY-LAW NO. 2018 - 45

A by-law of the City of Ottawa to confirm proceedings of the Council of the City of Ottawa at its meeting held on February 14, 2018.

WHEREAS subsection 5(1) of the *Municipal Act, 2001*, S.O. 2001, Chapter 25, as amended, provides that the powers of a municipal corporation are to be exercised by its council;

AND WHEREAS subsection 5(3) of the said *Municipal Act* provides that the powers of every council are to be exercised by by-law;

AND WHEREAS it is deemed expedient that the proceedings of the Council of the City of Ottawa at this meeting be confirmed and adopted by by-law;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. The action of the Council of the City of Ottawa in respect of each recommendation contained in Item 1 of Planning Committee Report 57; the report from the Ottawa Community Housing Corporation, entitled "Ottawa Community Housing Corporation (OCHC) Confirmation of Re-Election of Chair, Appointment of Directors, Repeal of By-Law No. 10, and Approval of By-Law No. 11"; the report from the Ottawa Police Services Board entitled "Board Activity, Training & Performance: 2017 Annual Report"; Agriculture and Rural Affairs Committee Report 31; Finance and Economic Development Committee Report 31; Planning Committee Report 57A and the report from the City Clerk and Solicitor's Office entitled "Summary of Oral and Written Public Submissions for Items Subject to the *Planning Act* 'Explanation Requirements' at the City Council Meeting of January 31, 2018", be received and adopted as amended, and any reports of committees and of local boards and commissions and each motion and resolution passed and other action taken by the Council of the City of Ottawa at this meeting is hereby adopted and confirmed as if all such proceedings were expressly embodied in this by-law.
2. The Mayor and the appropriate officials of the City of Ottawa are hereby authorized and directed to do all things necessary to give effect to the action of the Council of the City of Ottawa referred to in the preceding section.
3. The Mayor, or in the absence of the Mayor, the Deputy Mayor and the City Clerk, or in the absence of the City Clerk, the Deputy City Clerk, or in the absence of the City Clerk and the Deputy City Clerk, the Acting City Clerk are authorized and directed to execute all documents necessary in that behalf and to affix thereto the corporate seal of the City of Ottawa.
