BY-LAW NO. 2018 – 46

A by-law of the City of Ottawa to amend By-law 2007-268 respecting fees and charges for public transit services.

WHEREAS at its meeting of December 13, 2017, by way of Motion 62/12, Council approved the 2018 budget including the increase of or creation of certain fees and charges to come into effect on January 1, 2018;

AND WHEREAS By-law No. 2017-417 confirms the proceedings of Council of December 13, 2017;

NOW THEREFORE Council enacts as follows:

1. Schedule “B”, Park and Ride Lots and Associated Fees, and Schedule “C”, Fares for Transit Services, of By-law No. 2007-268 entitled “A by-law of the City of Ottawa respecting public transit”, as amended, are repealed and the Schedule “B”, Park and Ride Lots and Associated Fees, and the Schedule “C”, Fares for Transit Services, annexed hereto, are substituted therefor.
2. This by-law is deemed to have come into force on January 1, 2018.
