BY-LAW No. 2018 – 62

A by-law of the City of Ottawa to repeal By-law No. 2017-30 and to amend By-law No. 2007-452 respecting tax deferral program fees.

WHEREAS at its meeting of December 13, 2017, by way of Motion 62/12, Council approved the 2018 budget including the increase of or creation of certain fees and charges to come into effect on January 1, 2018;

AND WHEREAS By-law No. 2017-417 confirms the proceedings of Council of December 13, 2017;

NOW THEREFORE Council of the City of Ottawa enacts as follows:

1. Subsection 7(1) of By-law No. 2007-452 entitled “A by-law of the City of Ottawa to establish a tax deferral program for low-income seniors and low-income persons with disabilities who are owners of real property in the residential/farm property class”, as amended, is amended by striking out the dollar figure “\$121” where it occurs therein and substituting the dollar figure “\$123” therefor.
2. Subsection 7(2) of the said By-law No. 2007-452 is amended by striking out the dollar figure “\$42.00” where it occurs and substituting the dollar figure “\$43.00” therefor.
3. By-law No. 2017-30 entitled “A by-law of the City of Ottawa to amend By-law 2007-452 respecting tax deferral program fees” is repealed.
4. This by-law is deemed to have come into force and take effect on January 1, 2018.
