BY-LAW NO. 2018 - 66

A by-law of the City of Ottawa to change the name of rue Elm Street, avenue Empress Avenue, rue Laurel Street, rue Louisa Street, rue Nepean Street, avenue Primrose Avenue, rue Spruce Street, rue Waverley Street and rue Young Street, municipal highways in the City of Ottawa.

WHEREAS the Council of the City of Ottawa desires to assign a new name to certain municipal highways in the City of Ottawa;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. That "rue Elm Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Elm Street West/ouest".
2. That "avenue Empress Avenue" in the City of Ottawa, described in Schedule "A" shall be assigned the name "avenue Empress Avenue North/nord".
3. That "rue Laurel Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Laurel Street East/est".
4. That "rue Louisa Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Louisa Street West/ouest".
5. That "rue Nepean Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Nepean Street West/ouest".
6. That "avenue Primrose Avenue" in the City of Ottawa, described in Schedule "A" shall be assigned the name "avenue Primrose Avenue East/est".
7. That "rue Spruce Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Spruce Street West/ouest".
8. That "rue Waverley Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Waverley Street West/ouest".
9. That "rue Young Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Young Street East/est".
10. That Schedule "A" form part of this by-law.

11. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
