BY-LAW NO. 2018 - 69

A by-law of the City of Ottawa to amend By-law 2016-326 respecting fees for permanent signs on private property and to repeal By-law 2017-5.

WHEREAS at its meeting of December 13, 2017, by way of Motion 62/12, Council approved the 2018 budget including the increase of or creation of certain fees and charges to come into effect on January 1, 2018;

AND WHEREAS By-law 2017-417 confirms the proceedings of Council of December 13, 2017;

NOW THEREFORE the Council of the City of Ottawa enacts as follows:

1. Schedule "A", of By-law No. 2016-326 entitled "A by-law of the City of Ottawa regulating permanent signs on private property", as amended is repealed and Schedule "A", annexed hereto is substituted in its place.
2. By-law 2017-5 entitled "A by-law of the City of Ottawa to amend By-law 2016-326 respecting fees for permanent signs on private property" is repealed.
3. This by-law is deemed to have come into force on January 1, 2018.
