BY-LAW NO. 2018 - 119

A by-law of the City of Ottawa to establish certain lands as common and public highway and assume it for public use (Bandelier Way, Geranium Walk, Kimpton Drive, Samantha Eastop Avenue, Winterset Place, Discovery Crescent, Eagle Crest Heights).

WHEREAS the Council of the City of Ottawa deems it appropriate to establish as common and public highway and assume for public use certain lands in the City of Ottawa;

AND WHEREAS Section 31 of the Municipal Act, 2001, S.O. 2001, c.25, empowers a municipality to pass a by-law for establishing and laying out highways;

AND WHEREAS in accordance with subsection 5(2) of the City of Ottawa Act, 1999 being Schedule E to the Fewer Municipal Politicians Act, 1999, c. 14, S.O. 1999, the City of Ottawa stands in the place of the old municipalities as defined under the Act for all purposes;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. The following lands are hereby established as common and public highways and assumed for public use:

- a) Reserve Block 285 on Registered Plan 4M-1597, City of Ottawa (voie Bandelier Way).
- b) Reserve Blocks 286, 287 and 288 on Registered Plan 4M-1597, City of Ottawa (cour Geranium Walk).
- c) Reserve Blocks 289, 290, 291, 292, 295, 297 and 298 on Registered Plan 4M-1597, City of Ottawa (promenade Kimpton Drive).
- d) Reserve Blocks 293, 294 and 301 on Registered Plan 4M-1597, City of Ottawa (avenue Samantha Eastop Avenue).
- e) Reserve Blocks 296 and 299 on Registered Plan 4M-1597, City of Ottawa (place Winterset Place).
- f) Reserve Block 300 on Registered Plan 4M-1597, City of Ottawa (croissant Discovery Crescent).
- g) Reserve Block 302 on Registered Plan 4M-1597, City of Ottawa (plateau Eagle Crest Heights).

2. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
