BY-LAW NO. 2018 - 131

A by-law of the City of Ottawa to repeal By-law No. 2017-388 and to change the name of rue Ottawa Street, rue Cockburn Street, rue Burke Street, rue Lennox Street and chemin Frank Kenny Road, municipal highways in the City of Ottawa.

WHEREAS the Council of the City of Ottawa desires to assign a new name to certain municipal highways in the City of Ottawa;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. That "rue Ottawa Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Ottawa Street West/Ouest".
2. That "rue Cockburn Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Cockburn Street South/Sud".
3. That "rue Burke Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Burke Street East/Est".
4. That "rue Lennox Street" in the City of Ottawa, described in Schedule "A" shall be assigned the name "rue Lennox Street South/Sud".
5. That "chemin Frank Kenny Road" in the City of Ottawa, described in Schedule "A" shall be assigned the name "chemin Cox Country Road".
6. That Schedule "A" form part of this by-law.
7. That By-law No. 2017-388 entitled "A by-law of the City of Ottawa to change the name of rue Ottawa Street, rue Cockburn Street, rue Burke Street, rue Lennox Street, chemin Frank Kenny Road, terrasse Rideau Terrace and croissant Davidson Crescent municipal highways in the City of Ottawa." is hereby repealed.
8. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
