BY-LAW NO. 2018 - 132

A by-law of the City of Ottawa to amend By-law No. 2001-17 to appoint certain Inspectors, Property Standards Officers and Municipal Law Enforcement Officers in the Building Code Services Branch of the Planning, Infrastructure and Economic Development Department.

The Council of the City of Ottawa enacts as follows:

1. Section 1 of By-law No. 2001-17, entitled, "A by-law of the City of Ottawa to appoint certain Inspectors, Property Standards Officers and Municipal Law Enforcement Officers in the Building Code Services Branch of the Planning, Infrastructure and Economic Development Department", as amended, is amended by adding the following persons:

2. Section 3 of By-law No. 2001 - 17 entitled, "A by-law of the City of Ottawa to appoint certain Inspectors, Property Standards Officers and Municipal Law Enforcement Officers in the Building Code Services Branch of the Planning, Infrastructure and Economic Development Department", as amended, is repealed and replaced by the following:
