BY-LAW NO. 2018 - 137

A by-law of the City of Ottawa to establish the Britannia Village Area within the City of Ottawa as a designated area for a special service.

AND WHEREAS section 326 of the Municipal Act, S.O. 2001, c25, as amended, provides that the local municipality may identify a special service of the municipality and designate the area of the municipality in which the residents and property owners receive or will receive an additional benefit from the special service;

AND WHEREAS on February 14, 2018 the Council of the City identified the Britannia Village Ottawa River Flood Protection as a special service to be provided within the Britannia Village Area described in Schedule "A" ("Britannia Village");

THEREFORE the Council of the City of Ottawa enacts as follows:

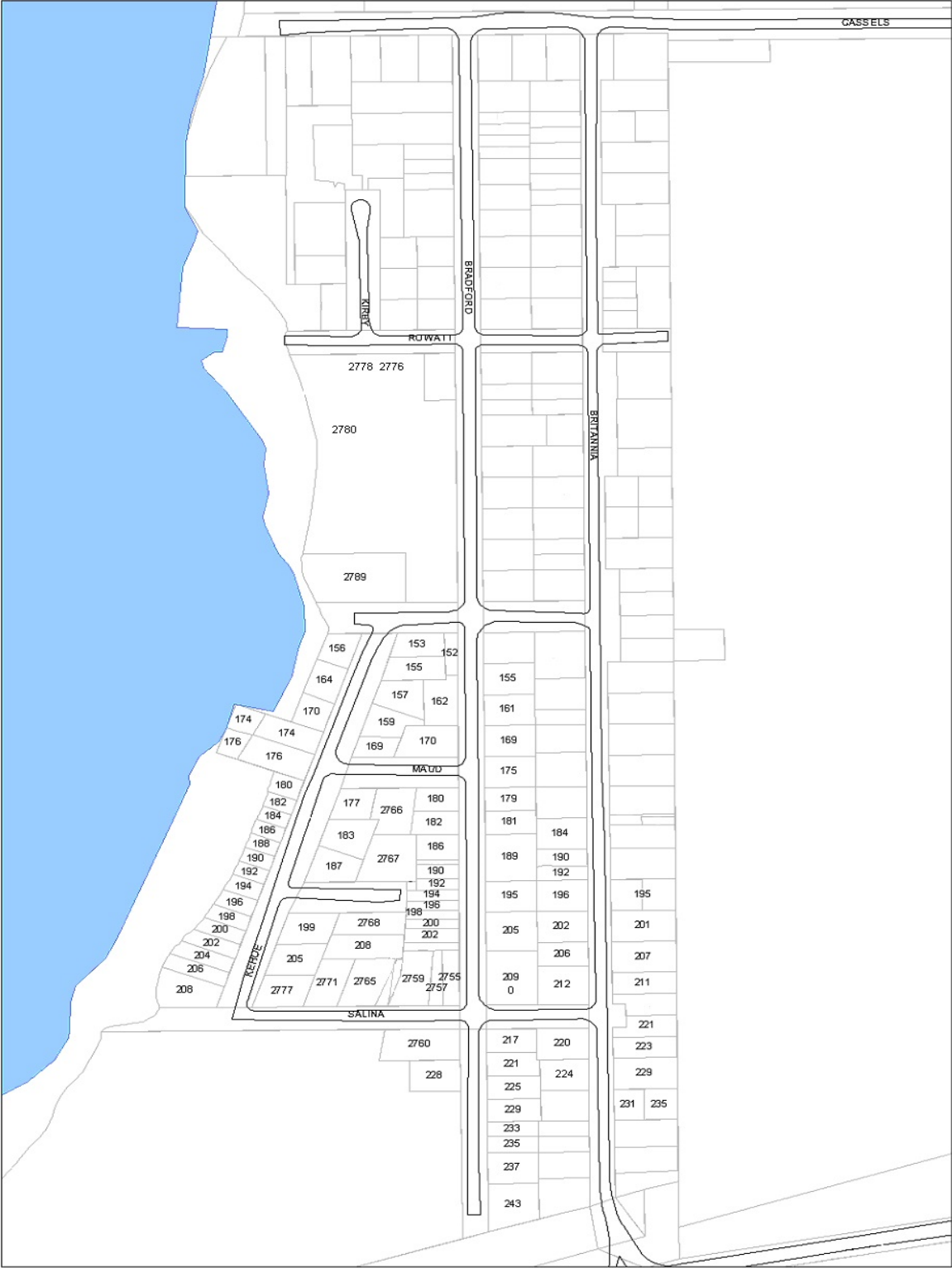
1. The City of Ottawa will provide the Britannia Village Ottawa River flood protection ("special service") within the area known as the Britannia Village described in Schedule "A" attached to this by-law.
2. Britannia Village is an area within which a benefit is derived from the provision of the special service.
3. Schedule "A" entitled "Britannia Village Ottawa River Flood Protection" identifying the Britannia Village area shall be and forms part of this by-law.

ENACTED AND PASSED this 9th day of May, 2018.
