BY-LAW NO. 2018 - 152

A by-law of the City of Ottawa to establish a special levy for the Canterbury Community Outdoor Covered Refrigerated Rink Facility within the service area known as the Canterbury designated area for the year 2018.

WHEREAS the City may establish one or more special services areas and levy one or more special services area levies pursuant to sections 312 and 326 of the *Municipal Act*, 2001, S.O. 2001, Chapter 25, as amended;

AND WHEREAS it is necessary for the Council of the City of Ottawa to levy on the assessment in each property class in the Canterbury Community Outdoor Covered Refrigerated Rink Facility and Special Area rateable according to the last assessment roll for the City of Ottawa as amended by the Municipal Property Assessment Corporation the rates set forth in Schedule "A" hereto attached for the purpose of community and recreational services in the Canterbury Community Outdoor Covered Refrigerated Rink Facility and Special Area;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. In this by-law, "Canterbury Community Outdoor Covered Refrigerated Rink Facility and Special Area" means the Canterbury Community Outdoor Covered Refrigerated Rink Facility and Special Area as established pursuant to By-law No. 2016-161 of the City of Ottawa.
2. For the year 2018, there shall be levied and collected on the assessment in each property class in the Canterbury Community Outdoor Covered Refrigerated Rink Facility and Special Area in the City of Ottawa according to the last assessment roll for the City of Ottawa as amended by the Municipal Property Assessment Corporation, the special local municipal levy at the rates of taxation as set out in Schedule "A", attached hereto.
3. The amount raised by the levy provided for in this by-law shall be reduced by the amount previously raised by the interim levy in 2018 and collected.
4. For payment-in-lieu of taxes due to the City of Ottawa, the actual amount due to the City of Ottawa shall be based on the last assessment roll for the City of Ottawa as amended by the Municipal Property Assessment Corporation and the tax rates for the year 2018.
5. That every owner shall be taxed according to the tax rates in this by-law.
6. If any section or portion of the by-law or of Schedule "A" is found by a court of competent jurisdiction to be invalid it is the intent of the Council of the City of Ottawa that all remaining sections and portions of this by-law and of Schedule "A" continue in force and effect.

7. Schedule "A" attached hereto shall be and forms a part of this by-law.
