BY-LAW NO. 2018 – 161

A by-law of the City of Ottawa to amend By-law No. 2003-462 respecting various minor amendments.

The Council of the City of Ottawa enacts as follows:

1. Section 1 of By-law No. 2003-462 entitled “A by-law of the City of Ottawa respecting the erection, height and maintenance of fences.”, as amended, is amended by repealing the definition of “fence” and substituting the following definition therefor:

“fence” means any freestanding structure, wall or barrier other than a building, erected at grade for the purpose of delineating the boundaries of a property, restricting ingress to or egress from a property, or providing security or protection to property, and does not include a hedge;

2. Section 1 of the said By-law No. 2003-462 is further amended by adding the following definition:

“finished side” means that the fence construction is completed, where either both sides of the fence have the same appearance, or the side that is not facing the fence owner’s property is free of evidence of structural components, such as posts, and is the most aesthetically attractive;

3. The said By-law 2003-462 is amended by repealing the heading “INTERPRETATION” immediately preceding Section 2.

4. Section 2 of the said By-law No. 2003-462 is repealed.

5. Section 6 of the said By-law No. 2003-462 is amended by repealing the words “Section 5” and substituting the words “Section 4” therefor.

6. Section 7 of the said By-law No. 2003-462 is amended by repealing the words “Section 6” and substituting the words “Section 5” therefor.

7. Section 8 of the said By-law No. 2003-462 is amended by repealing the words “Section 6” and substituting the words “Section 5” therefor.

8. Section 8 of the said By-law No. 2003-462 is further amended by repealing the words “described in Schedule “A” annexed to this by-law” and substituting the words “as prescribed in the Official Plan” therefor.

9. Section 11 of the said By-law No. 2003-462 is amended by repealing the words “Section 6” and substituting the words “Section 5” therefor.

10. Section 16 of the said By-law No. 2003-462 is amended by repealing the words “, as determined by the Director of By-law Services,”.

11. Section 17 of the said By-law No. 2003-462 is amended by repealing the words "Section 14" and substituting the words "Section 13" therefor.
12. Section 20 of the said By-law No. 2003-462 is amended by repealing the words "Section 9" and substituting the words "Section 8" therefor.
13. Section 21 of the said By-law No. 2003-462 is amended by repealing the words "Sections 6 and 9" and substituting the words "Sections 5 and 8" therefor.
14. Section 22 of the said By-law No. 2003-462 is amended by repealing the words "Section 6 and Section 9" and substituting the words "Section 5 and Section 8" therefor.
15. Sections 3 to 33 of the said By-law No. 2003-462 are renumbered as Sections 2 to 32 respectively.
16. Schedule "A" of the said By-law No. 2003-462 is repealed.
