BY-LAW NO. 2018 - 183

A by-law of the City of Ottawa to establish certain lands as common and public highway and assume it for public use (promenade Parade Drive, voie Campolina Way, croissant Stallion Crescent and voie Hickstead Way).

WHEREAS the Council of the City of Ottawa deems it appropriate to establish as common and public highway and assume for public use certain lands in the City of Ottawa;

AND WHEREAS Section 31 of the Municipal Act, 2001, S.O. 2001, c.25, empowers a municipality to pass a by-law for establishing and laying out highways;

AND WHEREAS in accordance with subsection 5(2) of the City of Ottawa Act, 1999 being Schedule E to the Fewer Municipal Politicians Act, 1999, c. 14, S.O. 1999, the City of Ottawa stands in the place of the old municipalities as defined under the Act for all purposes;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. The following lands are hereby established as common and public highways and assumed for public use:
 - a) Reserve Blocks 390, 391, 396, 397, 398 and 400 on Plan 4M-1589, City of Ottawa (promenade Parade Drive).
 - b) Reserve Block 392, Plan 4M-1589, City of Ottawa (voie Campolina Way).
 - c) Reserve Blocks 393, 394 and 395, Plan 4M-1589, City of Ottawa (croissant Stallion Crescent).
 - d) Reserve Block 399. Plan 4M-1589, City of Ottawa (voie Hickstead Way)
2. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
