BY-LAW NO. 2018 - 188

A by-law of the City of Ottawa to amend By-law No. 2003-447 respecting fees for private approaches.

WHEREAS at its meeting of December 13, 2017, by way of Motion 62/12, Council approved the 2018 budget including the increase of or creation of certain fees and charges to come into effect on January 1, 2018;

AND WHEREAS By-law No. 2017-417 confirms the proceedings of Council of December 13, 2017;

NOW THEREFORE Council enacts as follows:

1. Schedule "A", Fees, of By-law No. 2003-447 entitled "A by-law of the City of Ottawa to regulate the use of private approaches", as amended, is repealed and the Schedule "A", Fees, annexed hereto is substituted therefor.
2. This by-law is deemed to have come into force on January 1, 2018.
