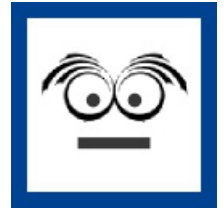

BY-LAW NO. 2018 - 189

A by-law of the City of Ottawa to amend By-law No. 2003-445 with respect to road cut fees.

WHEREAS at its meeting of December 13, 2017, by way of Motion 62/12, Council approved the 2018 budget including the increase of or creation of certain fees and charges to come into effect on January 1, 2018;

AND WHEREAS By-law No. 2017-417 confirms the proceedings of Council of December 13, 2017;

NOW THEREFORE Council enacts as follows:

1. Schedule "C", Road Cut Fees, of By-law No. 2003-445 entitled "A by-law of the City of Ottawa to regulate road activity on City highways", as amended, is repealed and the Schedule "C", Road Cut Fees, annexed hereto is substituted therefor.
2. This by-law is deemed to have come into force on January 1, 2018.
