BY-LAW NO. 2018 - 190

A by-law of the City of Ottawa to amend By-law No. 2017-92 respecting fees for ROW patios on City highways.

WHEREAS at its meeting of December 13, 2017, by way of Motion 62/12, Council approved the 2018 budget including the increase of or creation of certain fees and charges to come into effect on January 1, 2018;

AND WHEREAS By-law No. 2017-417 confirms the proceedings of Council of December 13, 2017;

NOW THEREFORE Council enacts as follows:

1. Schedule "A", Right of Way Patio Fees, of By-law No. 2017-92 entitled "A by-law of the City of Ottawa to regulate Right of Way patios on City highways", as amended, is repealed and the Schedule "A", Right of Way Patio Fees, annexed hereto is substituted therefor.
2. This by-law is deemed to have come into force on January 1, 2018.
