BY-LAW NO. 2018 - 191

A by-law of the City of Ottawa to amend By-law No. 2003-520 respecting the fees for certain signs and advertising devices on City roads.

WHEREAS at its meeting of December 13, 2017, by way of Motion 62/12, Council approved the 2018 budget including the increase of or creation of certain fees and charges to come into effect on January 1, 2018;

AND WHEREAS By-law No. 2017-417 confirms the proceedings of Council of December 13, 2017;

NOW THEREFORE Council enacts as follows:

1. Paragraph (c) of subsection 18(1) of By-law No. 2003-520 entitled "A by-law of the City of Ottawa to regulate signs and advertising devices on City roads", as amended, is repealed and the following paragraph is substituted therefor:

(c) a processing and technical review fee of one hundred and fifteen dollars (\$115.00) and a permit fee of one thousand, two hundred and seventy (\$1270.00) are paid for each system of signs, both of which fees are non-refundable in whole or in part,

2. Subsection 18(3) of the said By-law No. 2003-520 is repealed and the following subsection is substituted therefor:

(3) The permit referred to in subsection (1) of this Section may be renewed by the applicant annually, by application to the City, and by payment of a renewal permit fee for each year of renewal of one thousand, two hundred and seventy dollars (\$1270.00) for each system of signs, which fee is not refundable in whole or in part.

3. Paragraph (a) of subsection 18A(2) of the said By-law No. 2003-520 is repealed and the following paragraph is substituted therefor:

(a) the applicant shall pay an administrative fee of ninety-five dollars (\$95.00).

4. Paragraph (b) of subsection 14(2) of the said By-law No. 2003-520 is repealed and the following paragraph is substituted therefor:

(b) a processing fee of fifty-nine dollars and twenty cents (\$59.20) is paid per group of decorative banners and per street banner, which is not refundable in whole or in part,

5. Paragraph (c) of subsection 14(2) of the said By-law No. 2003-520 is repealed and the following paragraph is substituted therefor:

(c) an inspection fee of fifty-nine dollars and twenty cents (\$59.20) is paid per group of decorative banners and per street banner, which is not refundable in whole or in part,

6. This by-law is deemed to have come into force on January 1, 2018.
