BY-LAW NO. 2018 - 209

A by-law of the City of Ottawa to impose special annual drainage rates upon lands in respect of which money is borrowed under the *Tile Drainage Act*. R.S.O. 1990, c.T.8.

WHEREAS owners of land in the City of Ottawa have applied to Council of the City of Ottawa under the *Tile Drainage Act*, R.S.O. 1990, c.T.8 for loans for the purpose of constructing subsurface drainage works on such land;

AND WHEREAS Council of the City of Ottawa has, upon the application of the owners, lent the owners the sum of \$27,900.00 to be repaid with interest by means of rates hereinafter imposed;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. Annual rates as set out in Schedule "A" annexed hereto are hereby imposed upon such lands as described for a period of ten years, such rates to be levied and collected in the same manner as taxes.
