BY-LAW NO. 2018 - 210

A by-law of the City of Ottawa to establish certain lands as common and public highway and assume them for public use (Lafontaine Avenue, Frank Kenny Road, Greenbank Road, Cambrian Road, Parkdale Avenue, Burnside Avenue, Norice Street, Leitrim Road, Rochester Street, Preston Street, Bridge Street, Greenfield Avenue, McArton Road, Thomas A. Dolan Parkway, Prince of Wales Drive).

WHEREAS the Council of the City of Ottawa deems it appropriate to establish as common and public highway and assume for public use certain lands in the City of Ottawa;

AND WHEREAS Section 31 of the Municipal Act, 2001, S.O. 2001, c.25, empowers a municipality to pass a by-law for establishing and laying out highways;

AND WHEREAS in accordance with subsection 5(2) of the City of Ottawa Act, 1999 being Schedule E to the Fewer Municipal Politicians Act, 1999, c. 14, S.O. 1999, the City of Ottawa stands in the place of the old municipalities as defined under the Act for all purposes;

THEREFORE, the Council of the City of Ottawa enacts as follows:

1. The following lands are hereby established as common and public highway and assumed for public use:

- (1) (Lafontaine Avenue)  
Part of Lot 139, Plan 238 designated as Part 1 on Plan 5R-5140, City of Ottawa.
- (2) (Frank Kenny Road)  
Part of Lot 26, Concession 8, Cumberland, designated as Part 3 on Plan 4R-14817, City of Ottawa.
- (3) (Greenbank Road)  
Part of Lot 10, Concession 2, Rideau Front, Nepean, designated as Part 5 on Plan 4R-24037, City of Ottawa.
- (4) (Cambrian Road)  
Part of Lot 10, Concession 2, Rideau Front, Nepean, designated as Parts 6 and 7 on Plan 4R-24037, City of Ottawa.
- (5) (Parkdale Avenue)  
Part of Lot 3, Plan 41, E Parkdale Avenue (formerly Fifth Street) designated as Part 1 on Plan 4R-30618, City of Ottawa.
- (6) (Parkdale Avenue)  
Part of Lot 2, Plan 41, E Parkdale Avenue (formerly Fifth Street) designated as Part 2 on Plan 4R-30618, City of Ottawa.

- (7) (Parkdale Avenue)  
Part of Lot 1, Plan 41, E Parkdale Avenue (formerly Fifth Street) designated as Parts 3 and 4 on Plan 4R-30618, City of Ottawa.
- (8) (Burnside Avenue)  
Part of Lot 1, Plan 41, E Parkdale Avenue (formerly Fifth Street) designated as Part 5 on Plan 4R-30618, City of Ottawa.
- (9) (Norice Street)  
Part of Lot 32, Concession 1, Rideau Front, Nepean, designated as Parts 5 and 6, on Plan 4R-30799, City of Ottawa.
- (10) (Leitrim Road)  
Part of Lot 16, Concession 3, Rideau Front, Gloucester, designated as Part 1 on Plan 4R-28935, City of Ottawa.
- (11) (Rochester Street)  
Part of Lots 1587 to 1592, Plan 39 and Part of Lots 99 to 102, Plan 194250, designated as Part 6 on Plan 4R-22812, City of Ottawa.
- (12) (Preston Street)  
Part of Block 132, Plan 13 and Part of Lots 1 to 4, Plan 194250 designated as Part 7 on Plan 4R-22812, City of Ottawa.
- (13) (Bridge Street)  
Part of Lot 1, Concession A (Broken Front), N Gower, designated as Part 1 on Plan 4R-30384, City of Ottawa.
- (14) (Greenfield Avenue)  
Part of Lot 5, Plan 48, North Havelock Street, designated as Parts 1 and 2 on Plan 4R-30747, City of Ottawa.
- (15) (McArton Road)  
Part of Lot 2, Concession 12, Goulbourn, designated as Part 3 on Plan 4R-30961, City of Ottawa.
- (16) (Thomas A. Dolan Parkway)  
Part of Lot 27, Concession 5, March, designated as Part 1 on Plan 4R-30958, City of Ottawa.
- (17) (Prince of Wales Drive)  
Part of Lot 34, Concession B, Rideau Front, Nepean, designated as Part 8 on Plan 4R-29981, City of Ottawa.

2. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.
