BY-LAW NO. 2018 – 230

A by-law of the City of Ottawa to amend By-law No. 2016-303 respecting a minor administrative amendment.

The Council of the City of Ottawa enacts as follows:

1. Section 1 of By-law No. 2016-303 entitled “A by-law of the City of Ottawa respecting the use of water pipes in public places and workplaces.” is amended as follows:

- (a) deleting the definition of “Electronic Cigarettes Act” in its entirety and adding the following definition in alphabetical order:

“Smoke-Free Ontario Act, 2017” means the *Smoke-Free Ontario Act, 2017*, S.O. 2017, c. 26, Sch. 3, as amended, and any regulation passed under it, or any successor legislation thereto;

- (b) replacing the words “Electronic Cigarettes Act” where it appears in the definition of “water pipe” and replacing it with the words “Smoke-Free Ontario Act, 2017”.

2. This by-law shall come into force and take effect on July 1, 2018.
