A by-law of the City of Ottawa to amend By-law No. 2008-250 to change the zoning of the lands known municipally as 1569, 1573 Laperriere Street.

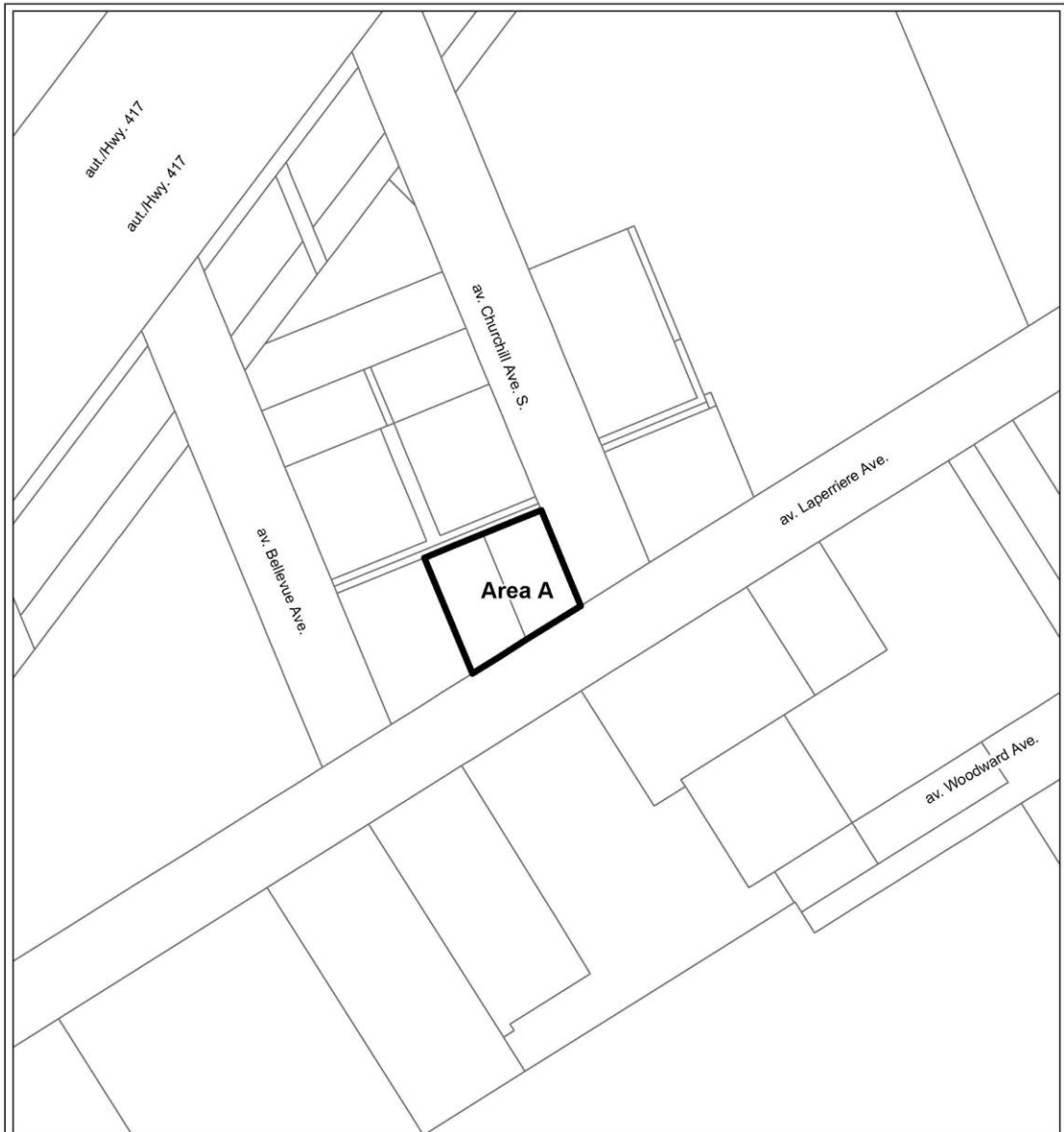
The Council of the City of Ottawa, pursuant to Section 34 of the *Planning Act*, R.S.O.1990, enacts as follows:

1. The Zoning Map of By-law No. 2008-250, entitled the “City of Ottawa Zoning By-law” is amended by rezoning the lands shown as Area A on Attachment 1 to this by-law from IL[277] H(11)-h to IL H(11).
2. Section 239 – Urban Exceptions of the said By-law No. 2008-250 is amended by deleting exception 277.
