BY-LAW NO. 2018 - 245

A by-law of the City of Ottawa to change the name of promenade Riverside Drive, municipal highway in the City of Ottawa.

WHEREAS the Council of the City of Ottawa desires to assign a new name to certain municipal highways in the City of Ottawa;

THEREFORE the Council of the City of Ottawa enacts as follows:

1. That “promenade Riverside Drive” in the City of Ottawa, described in Schedule “A” shall be assigned the name “ruelle Frobisher Lane”.
2. That “promenade Riverside Drive” in the City of Ottawa, described in Schedule “A” shall be assigned the name “place Lycée Place”.
3. That “promenade Riverside Drive” in the City of Ottawa, described in Schedule “A” shall be assigned the name “place Hurdman Station Place”.
4. That Schedule “A” form part of this by-law.
5. This by-law shall come into force and take effect when it has been registered in the Land Registry Division of Ottawa-Carleton.

## SCHEDULE "A"

The lands in Paragraph 1 affect the following PINs:

Part of PIN 04202-0240 (LT)

Part of Lots 14 and 15, Concession Junction Gore, Geographic Township of Gloucester, lying north of a line drawn from the southerly corner of Part 7, Plan 4R-8472 to the south westerly corner of Part 1, Plan 4R-28328 and south of the westerly extension of the southerly limit of Part 1, Expropriation Plan CT203891, being part of a forced road known as Riverside Drive.

The lands in Paragraph 2 affect the following PIN:

Part of PIN 04202-0240 (LT)

Part of Lots 12, 13 and 14, Concession Junction Gore, Geographic Township of Gloucester, lying north of the westerly extension of the northerly limit of Part 1, Expropriation Plan CT203891 and south of the southerly limit of Parts 4 and 5, Plan 4R-8020, being part of a forced road known as Riverside Drive.

The lands in Paragraph 3 affect the following PIN:

Part of PIN 04203-0706 (LT)

Part of Lot 12, Concession Junction Gore, Geographic Township of Gloucester, lying north of the northerly limit of Part 5, Plan 4R-8020 and south of Part 206, Plan 5R-238, being part of a forced road known as Riverside Drive.
