BY-LAW NO. 2018 - 272

A by-law of the City of Ottawa to amend By-law No. 2008-250 to change the zoning of part of the lands within the Spring Valley Trails Subdivision.

The Council of the City of Ottawa, pursuant to Section 34 of the *Planning Act*, R.S.O.1990, enacts as follows:

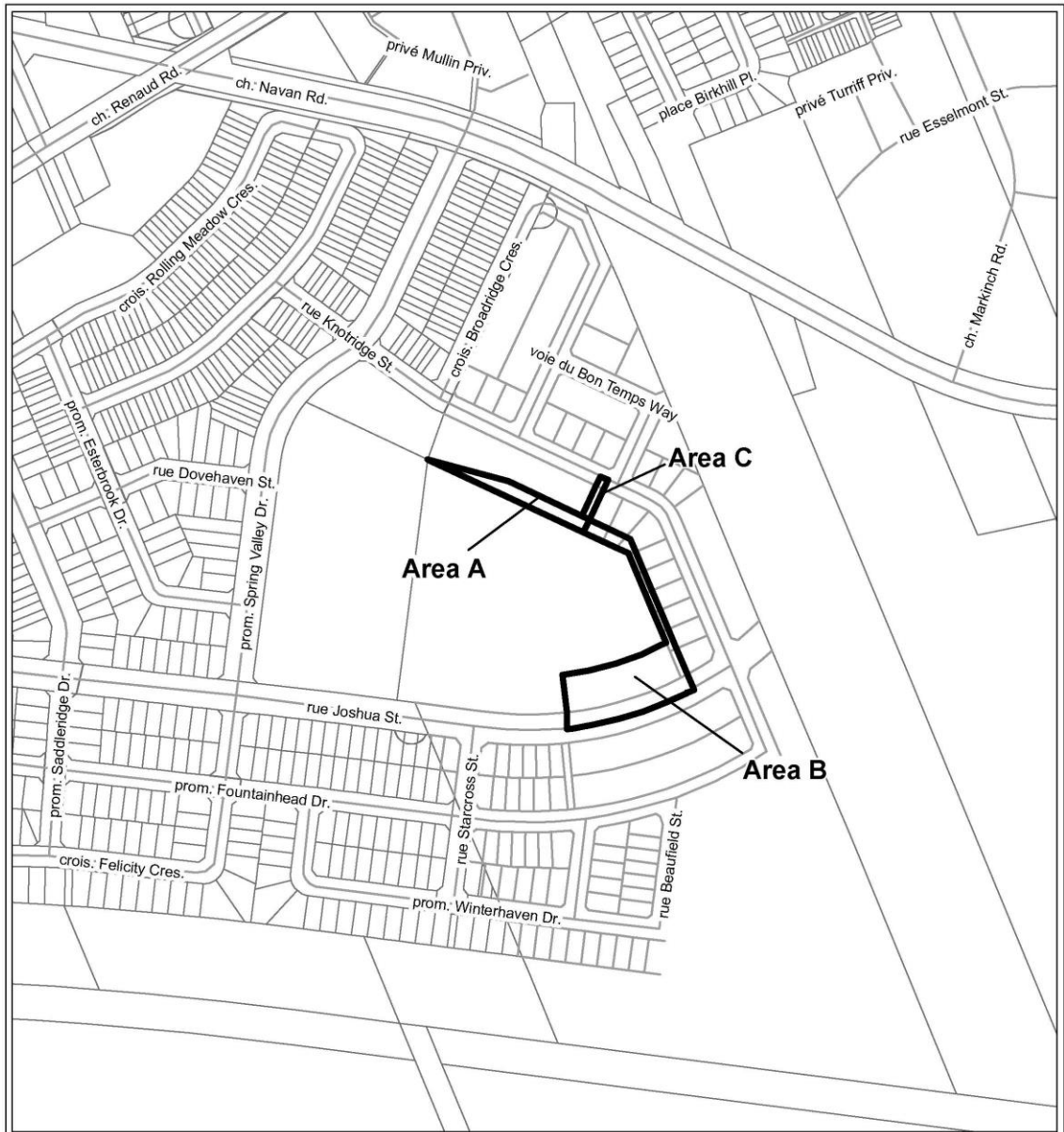
1. The Zoning Map of By-law No. 2008-250, entitled the “City of Ottawa Zoning By-law” is amended by rezoning the lands shown on Attachment 1 to this by-law as follows:



- (a) Area A from I1E to O1;
- (b) Area B from I1E to R3VV[1286]; and,
- (c) Area C from R3VV[1286] to O1.
