BY-LAW NO. 2018 – 274

A by-law of the City of Ottawa to repeal By-law No. 245-94 and to amend By-law No. 78-92 all of the former City of Ottawa respecting the Sparks Street Mall Business Improvement Area Board.

The Council of the City of Ottawa enacts as follows:

1. Section 4 of By-law No. 78-92 entitled “A by-law of The Corporation of the City of Ottawa to establish a Board of Management for the Sparks Street Improvement Area”, as amended, is amended by striking out the word “sixteen” where it occurs and substituting therefor the word “nine”.
2. By-law No. 245-94 entitled “A by-law of The Corporation of the City of Ottawa amending By-law Number 78-92 establishing the Board of Management for the Sparks Street improvement area” is repealed.
