BY-LAW NO. 2018 – 285

A by-law of the City of Ottawa to repeal by-laws numbered 2018-222, 2018-230, 2018-231, 2018-232, and 2018-233.

The Council of the City of Ottawa enacts as follows:

1. By-law No. 2018-222, entitled, “A by-law of the City of Ottawa to amend By-law No. 2018-449 respecting a minor administrative amendment.” is hereby repealed.
2. By-law No. 2018-230, entitled, “A by-law of the City of Ottawa to amend By-law No. 2016-303 respecting a minor administrative amendment.” is hereby repealed.
3. By-law No. 2018-231, entitled, “A by-law of the City of Ottawa to amend By-law No. 2003-446 respecting a minor administrative amendment.” is hereby repealed.
4. By-law No. 2018-232, entitled, “A by-law of the City of Ottawa to amend By-law No. 2017-92 respecting a minor administrative amendment.” is hereby repealed.
5. By-law No. 2018-233, entitled, “A by-law of the City of Ottawa to amend By-law No. 2008-448 respecting a minor administrative amendment.” is hereby repealed.
